St. Davids-Queenston United Church Annual Congregational Meeting Sunday, February 14, 2016 Immediately following the worship service at 11:31a.m.

Forty-four people in attendance.

Rev. James opened the meeting with a prayer.

Steve Hardaker resumed his position as Chair of the Congregation and Christine Earley resumed her position as Secretary of the Congregation.

- **<u>MOTION</u>**: To extend voting privileges to all in attendance, except on motions of church and spiritual policy. Moved by Anne Dorland and seconded by Pat MacDougall. All in favour.
- MOTION:To receive all reports as presented plus the Minutes from the previous Annual
Congregational Meeting, except the Budget and Nominating Committee Reports.
Moved by Nancy Lang and seconded by Verda Smith. All in favour.

Sue has assumed the role of Chair. Nikole Amato and Carol James are joining Christian Education Committee. Brook Bruce is joining Mission and Outreach. Bonnie and Clair Boyda are joining the Activities Committee. While not published in the report, Fred Van Nest is also a member of this committee. Susan Dobson has joined the Friendly Visitors and assumed the role of Chair. Joan Dunn is appointed to the Cave Springs Corporation.

FINANCE OPERATING INCOME AND EXPENSE REPORT FOR 2015

Presented by Al DesRoches

- Finished 2015 with a budget deficit of \$9,342.40. -\$7,994.94 operating / -1,347.46 capital)
- There was a 4% increase in envelope offerings over 2014, however, we missed our 2015 envelope giving income goal by 6.2%
- Many thanks to Darlene Romanowsky for preparing the Financial Statements

PROPOSED OPERATING INCOME AND EXPENSE BUDGET FOR 2016

Presented by Marianne McRae

Marianne thanked Al DesRoches for all the years of service as Chair of Finance.

- The Budget increase for 2016 is 7%
- Major factors contributing to the budget increase includes:
 - Ministry and Personnel expense increases as a result of addressing CRA guidelines and United Church of Canada imposed salary package restructuring.
 - Initially Presbytery dues were increased by 67%, however we, as well as 55 other churches protested and this increase was revised to 10%
 - o 16% increase in utility costs
 - We have included a buffer for Unforeseen expenses
- Of note is the Proposed Operating Income Budget, which outlines where program funding will come from. The income budget is \$162,246.88 and includes identifiable givings of \$138,836.88. This is an increase of 10.8% over the actual givings income for 2015. Also, proposed is a 43% increase in fundraising income over what was actually raised in support of operating expenses during 2015.
- The Minister's salary is all on one line in the Budget instead of split into several lines.
- We've had two years of deficits (2014 & 2015) and we've been working off our surplus. If everyone increased their givings by \$2 per week, we can meet our envelope givings goals for 2016. Please consider increasing your givings and going on PAR.

<u>MOTION</u>: That the Proposed Operating Expense Budget for 2016 of \$162,246.88 and the Proposed Operating Income Budget for 2016 of \$162,246.88 be approved.

Moved by Marianne McRae and seconded by Martha Fleming. All in favour.

Throughout the year, likely on a monthly basis, the Finance Committee will update the congregation on our Income Budget progress. Thank-you to the UCW for continuing to fund the church's insurance payment.

MISSION AND SERVICE

Presented by Jill Dill

Thank you to everyone who brought in supplies for John Bedell's Habitat for Humanity trip to India. He will be taking 4 boxes of supplies with him when he goes to India. For 2015, the commitment to the United Church of Canada Mission and Service Fund was \$15,000.00 and we missed our commitment by \$62.00. The Mission and Outreach Committee has recommended, and the Official Board agrees that the amount of \$15,000.00 be recommended to the Congregation as the 2016 commitment to the United Church Mission and Service Fund.

<u>MOTION</u>: To commit to a goal of \$15,000.00 for our 2016 contribution to the United Church of Canada Mission and Service Fund. Moved by Jill Dill and seconded by Al DesRoches. All in favour.

NEW BUSINESS

None.

Final comments by the Chair - Steve Hardaker

We would like to extend our heartfelt thanks to Rev. James for his spiritual leadership and ministry, to Lisa Brillon for her work with the Choir and her musical leadership, and to Darlene Romanowsky who put together the Annual Report and the Financial Statements and who basically runs the church.

Thank you to the Congregation for your continued generous support of the work of our church through your weekly givings, attendance at fundraising events and tireless volunteering at many church functions. This year will be a challenge as we strive to meet our income goals as set out in the budget approved today. With God's love, encouragement and help, we will meet these goals.

We would encourage the congregation to consider switching your weekly envelope givings to Pre-Authorized Remittance also known as PAR. PAR is a direct debit program that allows you to support your church through an automatic monthly withdrawal from your bank account, similar to how you pay many of your monthly bills. It means regular contributions throughout the year that make it easier for you to give to St. Davids-Queenston United Church and easy for our Finance Committee to track our income against our expenses. Since I switched to PAR, my annual givings increased and I didn't even notice it.

Jill Dill extended thanks from everyone to Steve Hardaker for his leadership as the Chair of the Congregational and Official Board.

Thank you to the UCW for providing for today's luncheon.

CONGREGATIONAL AND OFFICIAL BOARD CHAIR'S REMARKS

Hello friends. Once again this year we present the Annual Report for St. Davids-Queenston United Church. In this year's version you will read the reports of committee chairs and others who have contributed to sustaining our church family. I think you will find these reports full of interesting information. I look forward to officially presenting this report for your approval at our Annual Congregational Meeting on Sunday, February 19th after our worship service.

I'd like to use this space to recognize the work of the Official Board. The Official Board manages the operations of the church and met 7 times during the year. Through their faithful, dedicated efforts our church remains very healthy as we move into 2017. Here are a few highlights. More details are contained in the Annual Report. Ministry personnel, Finance, Session and the Christian Education have been deliberating over a number of remits that were approved at the 42nd General Council that could transform the structure of the United Church of Canada and the Basis of Union. Our Property Committee worked hard to complete and coordinate a number of church facility improvements, as well as submitted a loan and grant request to Extension Council that, if approved, will result in the paving of the majority of our parking lot this spring. Christian Education has concluded a very successful year of activities for the children and events to support our Sunday school. Our Mission and Outreach Committee worked to redistribute moneys raised during Tooney Sundays to a number of local, national and international bodies. Once again this year we exceeded our commitment to the United Church's Mission and Service Fund. Ministry and Personnel have now completed the task of bringing pay and compensation in line with both United Church and Canada Revenue Agency guidelines. Finally, our Finance Committee worked diligently to ensure our incoming revenues met our expenses. In fact, you will see that we have finished 2016 with a very healthy surplus of \$15,414.26. The Flower Committee continues to beautify our Sanctuary; the Activities Committee worked to bring a number of social and fund raising events to our church; and, our Friendly Visitors bring much needed love and fellowship to those who can't make it to normal worship services.

Once again this year, I am appealing to congregation members to consider switching your weekly envelope givings to Pre-Authorized Remittance (PAR). Presently there are 14 congregants using PAR. PAR allows members to support their church through an automatic monthly withdrawal from their bank account, similar to how you already pay many of your monthly bills. It makes it convenient for you to give to St. Davids-Queenston United Church. The more that use PAR, the easier it becomes to manage our budget. Let's double the number of members using PAR in 2017.

Please enjoy reading the 2016 Annual Report. Remain faithful! Share your fellowship! I look forward to seeing you in church! God bless you all!

FINANCE

The Finance committee report includes tables showing our income and expenses for 2106, our proposed expense & income budget for 2016 and our cash position and guaranteed investment certificates at December 31, 2016.

There are three separate spreadsheets showing our income and expenses for 2016. These spreadsheets found on Pages 20-23 show the Operating and Capital income and expenses for 2016. The Christian Education/Sunday School Project Income and Activity Expenses are also shown on these pages.

The finance committee is once again this year, honored to send out a sincere thank you to all the loving, compassionate and generous members of our church family who without a second thought are always ready to reach out to help where ever the need may be. Our plea at the end of 2015 was that we all work together to eliminate the deficit of \$7,994.94 we had incurred in 2015. With gratitude we are pleased to be able to present, thanks to the loyalty and generosity of all of you, not only the elimination of the deficit of 2015 but a very positive turn around with 2016 ending with an operating **surplus** of **\$15,414.26**.

Thank you to our steadfast **Activities Committee** who continued to work diligently on fundraising activities throughout the year raising money for both the operating and capital income. A total of **\$11,550.85** was raised for the **operating** income and **\$254.50** for the **Capital Income**.

The UCW with their amazing members worked very hard throughout the year and with their unwavering support, generously passed over **\$5000.00** to the operating account to pay the cost of the **Church insurance** and **\$2,120.76** to pay for the **new cupboards** in the Kitchen. They also transferred **\$1,856.64** to the **"Capital Project"** fund to pay for the second phase of the **"Front Landscaping"**.

We also received **\$6,215.00** from the **"Memorial Fund"** to cover the cost for a **"Cemetery Reference Plan"** prepared for the new section of the Cemetery. Both the Finance Committee and the Trustees are greatly appreciative for this generous assistance.

The Finance committee also recognizes and greatly appreciates the many individual members of our congregation who selflessly donate back to the church any cost incurred to them whether it be for purchasing routine kitchen supplies, food supplies for special dinners or for many other unforeseen costs with fundraising activities. These individuals pay for the necessary supplies, get a cheque in that amount from the church and then they exchange that cheque with a cheque written back to the church, by them, in that same amount. These individuals are credited for a donation of the amount given back to the church.

We are pleased that the Sunday school outings and activities have been self-supported by their own fundraising efforts.

On another positive note we are pleased to report that our Envelope offerings **increased by 18%** over 2015 and as well **exceeded** our proposed operating "income" budget for 2016 by **\$9,294.05**.

FINANCE HIGHLIGHTS

Operating Income

The Operating Income totaled \$180,202.09 for 2016. . Our major source of income comes from envelope offerings which totaled \$149,430.93. Fundraising supplemented our income by \$11,550.85. Internal donations (UCW/Memorial Fund) a business donation and Weddings & Rentals contributed \$14,145.76 to our income. The remaining source of income comes from HST Recovery, GIC interest and other miscellaneous items.

Operating Expenses

The operating expenses of **\$164,787.83** for 2016 when compared to the operating income of **\$180,202.09** resulted in a year end **surplus of \$15,414.26**.

Capital Income

The Capital Income totaled \$6,128.29. The source of income comes from internal donations (UCW), capital fundraising, personal donations, HST Recovery and GIC interest.

Capital Expense

The Capital Expenses of **\$6,238.30** for 2016 when compared to the Capital Income of **\$6,128.29** resulted in a year end **deficit** of **-\$110.01**.

Christian Education/Sunday School Project Income/Expense

A number of projects raised \$1,812.10 while \$1, 314.02 was disbursed for special activities and Vacation Bible school.. The year ended with a **surplus** of **\$498.08**

Proposed (Expense) Operating Budget for 2017

The proposed (Expense) Operating Budget was developed based on our expenditures in 2016 adjusting the budget to meet expected increases and some small decreases in 2017

The proposed budget for 2017 is **\$167,190.64** which is an **increase** of **\$5,210.76** or approximately 3% from 2016. The increases in the budgeted items are mostly based on routine increased expenses each year, including salary increases.

Keep in mind that any increase in "PAR" expenses represents an increase in congregation members who have chosen to have their donations to the church made as a "monthly preauthorized remittance" which is a "**financial planning asset** for the church".

Please note that the proposed budget for the "unforeseen expenses" was set at a number that would allow us to enter into a monthly payment for the anticipated loan from the "extension council" to be used to pave the church parking lot.

Proposed (Income) Operating budget for 2017

The proposed (Income) Operating Budget for 2017 is **\$167,190.64** which is an increase of \$4,943.76 or approximately 3% from 2016. This increase has been made in an attempt to have a balanced Income/Expense Budget. We have made the largest increase with the envelope offerings and a small increase in expected HST rebates. The other line items have either not been increased or have been decreased.

Financial Outlook

If we stay the course and repeat our success in 2016, we will surely be able to once again present a year end surplus in 2017. We ended 2015 with an operating deficit of -\$7994.94 but had a very positive turn around in 2016 with an operating surplus of \$15,414.26. This is assuredly a representation of a very devoted and generous congregation that we are all blessed to be a part of.

CWOP ANNUAL REPORT

Thank you for your continuing support for the Caribbean Workers Outreach Project. For the past 24 years a small group of Christian volunteers in Lincoln and Niagara on the Lake have cared for a ministry to support Agricultural workers (mainly Jamaican), who come each year to assist in farm work to benefit Niagara farmers. Each spring thousands of men (and a small group of women) leave family and home to travel to Niagara to work from 5 to 9 months, living on farms and saving or sending home their pay to support them and their families throughout the year. They cope with long working hours, extreme weather, isolation and loneliness. CWOP offers support to workers through five programmes.

- 1. Regular worship services are held in Lincoln and Niagara on Sunday evenings from late April to the end of June and both sides host a closing service at the end of August or early September. Each week volunteer drivers bring workers to services and return them to their farms. Local churches provide fruit, juice and cookies for the workers after each service. Visitors are welcome.
- 2. Each year two ministers from the United Church of Jamaica and the Cayman Islands come to Niagara for five weeks each, to lead worship and also to visit workers on farms in the evenings for friendly visits, sharing news from home and prayer. We need volunteer drivers to help ministers to travel from farm to farm and also to help workers get to Sunday evening services.
- 3. Each year we host workers from both sides for two events with friendly competition. A dominoes match in Lincoln on a Saturday evening and a Cricket Match in NOTL on a Sunday afternoon are highlights of the summer. Participants in the cricket Match get teams shirts and everyone shares in a special meal. There is no charge to workers for these events and transportation is provided.
- 4. We have a fund to provide benevolent support to workers who experience the death of a parent, spouse or child in Jamaica. This helps with the cost of airfare or funeral expenses. Support may be available at other times of crisis.
- 5. We host a breakfast early in June for minsters from Niagara and Lincoln churches to tell them about the programme, to offer an opportunity to meet with Jamaican ministers and to enlist their support in encouraging volunteers from their churches to sign up for our ministry.

This year we have several new volunteers on the Project Executive. Rev. Dave Pritchard (convenor) and Pastor Jim Wright have joined the Project executive. On the Lincoln side, Mary Ann Sclabach is stepping back and Allison Kruitbosch will take on responsibility as the coordinator. Rev. Anita Spiller, from Jordan Station United Church has joined the team and Jordan Station United Church has committed a significant donation to the project. Neil Ryckman and Annelies deGroot (treasurer) continue to be involved. On the NOTL side, Rev. Ted Power has taken on the coordinator role from Nancy King. Donna Brown (secretary) and Carol Miller continue. The Jamaican ministers who joined us this year were Rev. Lennox Scarlett (May) and Rev. Norlene Jackson (June). Next year (2017) we celebrate our 25th Anniversary. We are planning a special celebration evening in May and other special events. We will continue to share our plans with our partners and look forward to your support.

CAVE SPRINGS CAMP ANNUAL REPORT 2016

Cave Springs Camp has been blessed with another great year of serving the kingdom in several ways across Hamilton Conference. While our staff was smaller than we would have liked, Hannah and the directing team came together and helped us impact the lives of over 3000 campers, over the six months that we operate. This season saw another increase to our Day Camp program numbers, and a few new initiatives that are currently under way. Because of the gracious support of congregations along with the hard work of the board, I am happy to say that Cave Springs is in one of the best financial positions that I have seen throughout my time here. With that we have been working hard to maintain and upgrade the camp infrastructure. Also, we will be seeking your support as we re-visit and hopefully ramp up our Legacy Hall push again this year.

The summer was not without its difficulties. We faced a continual problem of staff shortage, and we had trouble finding enough well-equipped staff. The staff did well to make up for the extra work, but looking forward we need to find ways to improve our recruiting. We are also instating more thorough training for all staff, and this coming year will hopefully be one of growth in that department. Regardless of the challenges, our Day Camp numbers reached their highest ever, and we continue to see growth in that program. The fall program is still growing as well; what started out as just a few school groups has quickly grown into some great partnerships during that time of the year.

Niagara Presbytery has done a lot to support the camp with generous donations from congregations, individuals as well as the extension council. Many of the donations have gone towards the upkeep and maintenance of the site, and have allowed us to tackle long term projects, such as putting a new roof on Hoxie Hall. A lot of these contributions also helped to send kids to camp via our bursary fund, which regularly sponsors 10-15 campers to come to camp for a week–an experience they may not have been able to afford otherwise. We are also looking to the future with the blessings that we have received, consciously putting away funds to ensure the future of camp, and for expanding to new horizons.

We continue to move forward with the plans of building a new year-round lodge to replace the old (very old) Craft Hall. The new year-round facility will be names 'LEGACY' Hall. The board has chosen to review the plans, as they are almost 10 years old now! With this process we hope to re-ignite the flame to make this new facility a reality.

The Cave Springs Board has been a dedicated group of individuals who are working to further the kingdom of God through his vessel of Cave Springs. In the coming year we will be continuing a major capital appeal to fund the new building and will seek assistance from all our partners in funding our project. Please expect to hear more from us and be ready to respond, as you have in the past–generously and prayerfully. With our thanks and our prayers for blessing;
