## CHURCH BOARD AUTHORIZED ANNUAL MEETING TASKS

## **CHURCH BOARD MEETING HELD FEBRUARY 16, 2021**

## **During Covid-19 restrictions in 2021**

Following policy of the United Church of Canada, the Church Board was given authority to conduct a meeting as though it were the Annual General Congregational Meeting. This meeting was held on February 16, 2021 with the following information received and approved. In this regard the AGCM was postponed until February 2022.

## CHURCH BOARD, COMMITTEES AND EXTENSION COUNCIL

- Steve Hardaker, congregation chair, said that Sandra Macdonald has stepped down as one of the two Members At Large positions on the Church Board. Marie Vahrmeyer has agreed to fill that position.
- Steve then stated the following congregation members have agreed to join Church Board Committees:
  - Martha Fleming is joining the Flower Committee.
  - Esther Binning, Donna Cardinal, George Dunn, Joan Dunn, Monty Slingerland and Val Zuk are joining the Friendly Visitors. Congratulations to Chair Susan Dobson for a successful recruiting drive.
- o Steve then stated that Dianne Bergsma has stepped down as our Extension Council Representative. Marianne McRae has agreed to be our Extension Council Representative.
  - **Motion:** The Church Board approves the appointments of the congregation members named to new positions on the Church Board, Committees of the Church Board and Extension Council. **Moved** by Melanie Kelch, **seconded** by Linda Hardaker and carried by all.
- Steve said that Marie could not attend the meeting and was looking forward to participating in future meetings.
- Steve then thanked Dianne Bergsma, Anne Dorland and Marie Vahrmeyer who are stepping down from Worship and Faith Life Committee; Sandra Macdonald who has stepped down as one of our Members at Large on the Church Board; and, Al Des Roches, who has resigned as Chair and stepped down from the Trustees.
- There was a question as to why we don't have 2 representatives for the Regional Council. Larry McRae said that it is not a rule that we have 2 reps but it would be welcome and beneficial. We should try to get a 2nd representative.

## PROPOSED 2021 BUDGET

- Linda Hardaker gave an overview of the proposed budget for 2021 stating that the proposed budget was prepared with the consideration and hope that we would have a new minister by April.
  - **Motion:** That the Proposed Operating (Expense) Budget for 2021 of \$148,266.20 and the Proposed Operating (Income) Budget for 2021 of \$148,266.20 be approved. **Moved** by Marianne McRae, **seconded** by Florence Turner and carried by all.
- o Rev. Jones questioned if this information would be communicated to the congregation.
- O The proposed budget is in the Annual Report, but because we will not be having a congregational meeting as yet, Linda agreed that she would compose a letter regarding the proposed budget to be sent out to the congregation.

## **RESUMPTION OF IN-PERSON WORSHIP COMMITTEE**

In August 2020, the Church Board established an ad hoc committee in order to start planning for the safe return of in-person worshiping during the COVID-19 pandemic. The Resumption of Inperson Worship Committee was made up of Susan Dobson, Anne Dorland, Steve Hardaker (Chair), Rev. Doug Jones, Marianne McRae (Secretary), Wayne Philbrick, Florence Turner, Bill Utting and Nancy Utting (Public Health/Congregational Liaison). A task matrix was established and the committee met several times in 2020 to start completing the identified tasks. In October of 2020, the committee resolved to delay a recommendation to the Church Board to approve a return to in-person worship services until COVID-19 cases are reduced to a minimum level.

In 2021, the committee continued to work on the task matrix that included establishing a Workplace Safety Plan, a Return to In-person Worship Blueprint and a tutorial video illustrating what to expect when Congregation members return to church. The committee also started configuring the Sanctuary under the local public health restrictions. Plexiglass barriers were installed in front of the pulpit and lectern, a seating plan was established with adequate physical distancing, pew bibles and hymn books were removed as was the pew cushions. Volunteer Greeters and Ushers were recruited. A new COVID webpage was established on the church's website that included related documents and a weekly worship service registration form.

On July 29th, the Resumption of In-person Worship Committee met to discuss outstanding issues. The result was a motion to the Church Board recommending that approval be granted for the congregation to safely return to In-Person worship on Sunday, August 22<sup>nd</sup> with all appropriate Provincial and Niagara Region public health protocols in place. The committee further recommended establishing an on-line live-stream of our Sunday services so those who felt more comfortable worship from home, could do so.

The Resumption of In-person Worship Committee met for the last time on October 26<sup>th</sup>, 2021 in order to tidy up any loose ends and to consider recommending that the Church Board disband the committee. It was resolved that with every task on the task matrix now completed, that the Church Board officially disband this committee. During the Church Board Meeting on November 16, 2021, the Church Board disbanded the Resumption of In-person Worship Committee.

I would like to express my sincere appreciation to every member of this committee. Our task was complex and difficult as we juggled the ups and downs of the COVID-19 pandemic.

## **BOARD OF TRUSTEES**

I would like to begin, on behalf of the congregation to sincerely thanks those who serve as our 'Trustees' here at St. Davids-Queenston UC. They are: Rev. YongSeok Baek, Fred Van Nest, Howie Lowrey, Florence Turner, Clair Boyda, Tim Andrews, Wayne Mayer and Rev. Doug Jones. In keeping with COVID precautions the Trustees met via ZOOM this year.

Members were directed to and asked to review the updated (April 2021) Congregational Board of Trustees Handbook found on the UCC website.

Howie Lowrey continues to care for the finances of the committee. His report is included in our annual report.

Howie Lowrey notes that support of cemetery care comes from the congregation (\$5K) and \$3K from the town of NOTL. The cemetery continues to carry itself, however changes in the traditional approach to funerals (i.e. cremations rather than full burials) has negatively impacted income. Advertising was discussed with encouragement to use our website. (The 'About Us' section was noted).

In response to expressed concern signage was installed restricting only appropriate vehicle access to the cemetery. We, together with Property Committee members teamed up to trim the cemetery of overgrowth.

A review of current property insurance policy is underway. Rates have increased aprox. 30%. This is not due to COVID, rather to general increase in commercial rates due to claims. It was agreed to recommend to the Church Board that we renew the current policy however a review (inspection) of current needs (appropriate coverage) be reviewed in the coming year.

For the upcoming year we will be looking at:

- 1. Insurance policy review
- 2. Cemetery maintenance
- 3. Promotion of Cemetery plot sales

#### HORSESHOE FALLS REGIONAL COUNCIL REPORT

## October 14-16 (Meeting on Zoom)

The first session opened on Thursday October 14th at 6:30 pm with 104 in attendance. Once again there was a Welcome, Land Acknowledgement, Meditation, renewal of the Holy Manners and the Affirm Statement. In this segment the message from the President of Council, Rev Robert Lawson, centred on keeping a brave face lest we become hollowed out spiritually. We were encouraged to be ready to both talk about and actually be, brave. After the lighting of the Christ Candle we sang, at home on mute, Hymn 567 in VU, "Will you come and follow me."

The meeting then dealt with Proposal #1 concerning the Opening and Procedural Motions, including the Consent Docket. The motion Carried.

The section on Community Building with the topic "Be Bold, Be Brave" was then opened with a reading from Esther 4, v10-17, after which we went into breakout rooms to discuss the names of brave people either from the Bible or in real life. The second part of the exercise was to describe the action of the person mentioned, eg Job = perseverance. The time allotted for this whole discussion was about thirty-five minutes.

There was a presentation from the United Property Resource Corporation (UPRC) from the CEO, Tim Blair. He gave an explanation of the reason and the goal of the corporation. He said that UC property should be treated as an asset that could be used for a different purpose, eg from a church into affordable housing. The UPRC would be the developer and the church would remain viable as a part of the development. It is a country wide organization and is currently talking and working with forty churches in Ontario.

The session then moved on to Proposal #2 the Review of the YTD Financials. Some concern was expressed that the reports for 2019 and 2020 had not yet been finished and received. This was explained by the movement to the new Council system as well as new auditors who had not previously dealt with the United Church. However, at the end of the current six months we are on track to finish the year very close to the budgeted target. The Council would try not to use any unrestricted funds to cover any shortfalls.

This was then followed by Proposal #3, the appointment of PWC as auditors for 2021. After a brief discussion, the motion Carried.

At this point we had reached the Order of the Day and voted to extend the meeting time by 15 minutes to finish the business at hand.

Proposal #4 the Operating Budget for 2022 was presented. The motion Carried.

The President of Council gave a closing prayer talking about the breastplate of Saint Patrick, which starts "Christ with me, ..."

The session adjourned at 8:40 pm.

The morning session on Saturday the 16th started at 9:30 am with 101 present.

After the Welcome and Acknowledgement, the President expanded his thoughts about his message regarding feeling hollow at times. He also introduced a recorded message from some LLWLs about their decision to take on that role in the Church. We then sang the Hymn, Spirit God.

The next presentation was a report on the highlights of the Human Resources Commission. This included a video from Janice Pow, a Candidate for DLM.

A report was then given by Rev Dianne Everitt on the activities of the Covenant Commission, including the reading of the In Memoriam list.

## HORSESHOE FALLS REGIONAL COUNCIL REPORT Cont'd

The Mission and Discipleship Commission then gave a written report and an impromptu presentation by the Commission members present on what it is like to be on the Commission.

That was followed by a talk from Dave Jagger from General Council Mission and Service department. He stated that the Gifts with Vision catalogue can also include vaccinations for \$25.

He went on to say that there are two modules of "Call to be the Church" available for use in Sunday morning worship. There is also a Stewardship series that covers five weeks around Christmas, but can be adapted for use at any time.

We had a break time from 10:50 to 11:10 am.

When the session reconvened, we were sent into breakout rooms with the general topic "Connecting and Engaging in the Wider Church". The first question was "what has been lost in the last three years?" The general consensus was the lost contact with other churches in the area; no connection with other churches and the loss of church meals and personal interactions. The second session of breakout asked the question, "how is God calling you to go forward and build relationships with Regional Council?" Again, the consensus is that there is no clue on how to fix the loss of connection with other churches, but maybe sending out the minutes of the Covenanting Commission meetings would help with knowing more of the monthly operations of the Church.

At this time, according to the Agenda, there were no proposals to forward to General Council. Proposal #5 Closing Motions was then presented. This gives the power of the Regional Council

to the Executive until the next regular meeting in the Spring. It will be held May 27-29, 2022. It may be held in person in Fonthill, but that will be announced at a later time. The motion Carried.

The President then gave closing thanks, a closing prayer and a Blessing as well more of the quote attributed to St Patrick. We sang the Hymn "We Shall Go Out". Adjournment was at 12:25 pm.
