

St. Davids-Queenston United Church Annual Report 2017

St. Davids-Queenston United Church Annual Congregational Meeting Agenda Sunday, February 19, 2017 Immediately following the worship service.

Approximately 55 members were in attendance.

1. **PRAYER:** Rev. James opened the meeting with a prayer.

Steve Hardaker, Chairperson of the Congregation, announced that Marianne McRae has agreed to act as the Congregational Secretary.

<u>MOTION</u>: To extend voting privileges to all in attendance, except on motions of church and spiritual policy and the Nominating Committee Report. Moved by: Larry McRae; Seconded by: Bill Utting. <u>CARRIED</u>

2. <u>2016 ANNUAL REPORT</u>:

<u>MOTION</u>: To receive all reports as presented in the Annual Report of 2016 (including the Minutes from the previous Annual Congregational Meeting), except the 2017 Budget and Nominating Committee Reports. Moved by: Ron Chapman; Seconded by Nancy Lang. <u>CARRIED</u>

3. <u>2016 FINANCAL STATEMENT</u>:

Presented by Marianne McRae

- Sincere thanks were expressed to Darlene Romanowsky for the tremendous job she does in keeping the books so well-organized and in such detail.
- 2016 ended with an operating budget surplus of 15,414.26.
- There was an 18% increase in envelope offerings over 2015.
- The proposed 2016 operating income budget was exceeded by \$9,294.05!
- We had a very small deficit in Capital expenses of \$110.01.
- These figures do not include our contributions to the United Church Mission and Service Fund, which are dealt with separately.

4. 2017 OPERATING EXPENSE AND OPERATING INCOME BUDGET:

Presented by Marianne McRae

- A motion was passed at the Official Board on January 17, 2017 to recommend that the proposed budgets for the operating expenses of \$167,190.64 and operating income of \$167,190.64 be accepted and brought forward to the congregation for approval.
- The Budget increase for 2017 is approximately 3%.
- Major factors contributing to the budget increase include:
 - o Ministry and Personnel expense increases as a result of addressing CRA guidelines and United Church of Canada imposed salary package restructuring.
 - o utility costs
 - o routine expenses increases
- Of note is the Proposed Operating Income Budget, which outlines the sources of funding. The income budget is \$167,190.64 and includes identifiable givings of \$144,640.00.
- As a congregation, by approving the 2017 budget, we are committing to a balanced budget for 2017, so each member is encouraged to do their part in reaching this goal.

MOTION: That the Proposed Operating Expense Budget for 2017 of \$167,190.64 and the Proposed Operating Income Budget for 2017 of \$167,190.64 be approved.

Moved by: Marianne McRae; Seconded by Al Des Roches. CARRIED

- Throughout the year, the Finance Committee will update the congregation on the financial health of the congregation.
- A sincere vote of thanks was expressed to the UCW for continuing to fund the church's insurance payment and supporting several of the projects undertaken by the Property Committee.

5. MISSION AND SERVICE FUND:

Presented by Jill Dill

- For 2016, the commitment to the United Church of Canada Mission and Service Fund was \$15,000.00.
- For 2016, we exceeded our commitment by \$766.00. The Mission and Outreach Committee has recommended, and the Official Board agrees, that the amount of \$15,000.00 be proposed to the Congregation as the 2017 commitment to the United Church Mission and Service Fund
- Thanks were expressed to Rena Edgley for her many years of dedicated service to this committee and to Lillian Pyke and Bob Johnston for agreeing to serve on this committee

<u>MOTION</u>: To commit to a goal of \$15,000.00 for our 2017 contribution to the United Church of Canada Mission and Service Fund. Moved by: Jill Dill; Seconded by: Tony Gazzard. <u>CARRIED</u>

6. NOMINATING COMMITTEE:

Presented by Steve Hardaker

- We have some new nominees for <u>Church Committees</u> and the Official Board: Lyndsay Gazzard has agreed to serve on Session. Bob Kerr is joining the Property Committee. Gaye Benner is joining the Christian Education Committee. Nancy Lang has agreed to be the Interim Chair of Christian Education Committee and Lillian Pyke is joining Mission and Outreach Committee.
- Nominees for <u>Committees of the Official Board</u>: Judy Kerr is joining the Flower Committee. Bob and Judy Kerr are joining the Activities Committee.
- Marianne McRae has agreed to be the Congregational Secretary.
- Appointments to the Cave Springs Corporation and to the Extension Council are not being made and are therefore vacant. Anyone wishing to volunteer for these committees is encouraged to speak to Larry McRae or Steve Hardaker.

MOTION: To accept all positions as nominated. Moved by: Larry McRae; Seconded by: Bill Utting. <u>CARRIED</u>

- The following individuals were thanked for their past service on Church Committees and the Official Board: Harvey Hall has left the Property Committee; Ginny Slingerland is retiring from Ministry and Personnel; Christine Earley and Nikole Amato have left Christian Education and, Rena Edgley has retired from Mission and Outreach. In addition, Esther Binning and Bob Johnston have retired from the Friendly Visitors and Fred Van Nest has retired from the Activities Committee.
- Christine Earley is no longer the Congregational Secretary.
- Roberta Chevers has retired from the Trustees.
- Verda Smith has retired from managing the kitchen on behalf of the UCW. This has been taken over by Violet McArthur
- The following ladies received special recognition for their many years of faithful and dedicated service to the church and committees of the Official Board: Ginny Slingerland, Verda Smith, Rena Edgley and Roberta Chevers.

7. NEW BUSINESS

- George Dunn expressed thanks to the Activities Committee for their dedicated efforts. He suggested that the beef-on-a-bun events be advertised on Cogeco each month.
- Thanks were expressed to Rev. Paul James for his spiritual leadership and ministry.
- Thanks were expressed to Stephanie Morley for her dedication to the Sunday School.
- Thanks were expressed to Lisa Brillon for her work with the Choir and her musical leadership.
- Thank you to Darlene Romanowsky who put together the Annual Report and the Financial Statements. It was noted that Darlene is the voice of our church as she is usually the person answering the phone.
- Roy Harwood suggested that a fund be set up for the future where the interest, but not principle, is spent. He suggested contributions could be directed to this fund instead of memorial flowers. He further suggested that members consider the church in their wills. A special service could be held every year to recognize those who have contributed to this fund.
- Thanks were expressed to the Congregation for their continued generous support of the work of our church through weekly givings, attendance at fundraising events and tireless volunteering at many church functions. New members seem to come on a regular basis, so we must be doing something right. Special mention was made of the folks who make sure new people receive a warm welcome.
- Contributing members were encouraged to consider switching weekly envelope givings to Pre-Authorized Remittance (PAR) which is a direct debit program that allows you to support our church through an automatic monthly withdrawal from a bank account. It means regular contributions throughout the year that make it easier for you to give to the church and an advantage for our Finance Committee to track our income against our expenses.
- Anne Dorland expressed thanks to Steve Hardaker for his gracious and dedicated leadership.

<u>MOTION</u>: To close the congregational meeting. Moved by: Lyndsay Gazzard; seconded by Nancy Lang. <u>CARRIED</u>

Adjournment was at noon.

All present were invited to attend the luncheon following the meeting.

Creative Landscapes (Geoffrey Mayers, owner) has assumed the responsibility for selling and marking cemetery

plots. In the past this job has been undertaken by volunteers from the board of Trustees but it was felt that a younger

person would be able to assume the responsibilities for a longer period of time. Mr. Mayers agreed to fulfill the

responsibility of selling and marking out the grave plots.

It was discovered that the land upon which the cemetery is located, was never officially transferred to the trustees.

registered and the trustees now "officially" hold title to the land.

A presentation was made to the Trustees by a former member of the Queenston community to erect a fence between

the parking lot and the cemetery. The person proposing the fence is in the process of raising funds in the

community to pay for the project. Concerns were raised about both maintenance and accessibility to the cemetery.

The trustees requested further information about the proposal. As of December 31st, we have had no further

information.

The Trustees lost two valued and loved members of the Board this past year with the death of Jerry Bergsma and

Verda Smith. We miss their presence and their wisdom.

FINANCE

The Finance committee report includes tables showing our income and expenses for 2017, our proposed expense & income budget for 2017 and our cash position and guaranteed investment certificates at December 31, 2017.

The finance committee would like to sincerely thank all the congregation members for their continued support throughout the year. As a result of your loyalty and generosity we are pleased to present an **Operating** year end surplus of \$14,768.04.

Thanks, so much, for all those involved with the fundraising projects that had the profits designated to the Operating Income. The Easter Sunrise Breakfast, the ham dinner, the pie booth at the carnival, and the yard sale/barbeque raised a total of \$8,854.90.

We are very grateful to our tireless **Activities Committee** who continued with one Friday a month from January to June and September to November hosting the popular beef-on-a-bun/games night. With this fundraiser they designated the profits to the **Capital** project of replacing the sound system for the church. They raised **2,575.50** for the sound system.

Our very reliable, hardworking and thoughtful UCW members presented \$5000.00, once again in 2017, for the operating account to aid in the cost of the church insurance. This assistance is so greatly appreciated.

The Finance committee also recognizes and greatly appreciates the many individual members of our congregation who selflessly donate back to the church any cost incurred to them whether it be for purchasing routine kitchen supplies, food supplies for special dinners or for many other unforeseen costs with fundraising activities.

On another positive note we are pleased to report that our Envelope offerings increased by 3% over 2016 and as well we exceeded our proposed operating "income" budget for 2017 by approximately \$5000.00.

FINANCE HIGHLIGHTS

Operating Income

The Operating Income totaled \$173,315.60 for 2017. Our major source of income comes from envelope offerings which totaled \$154,435.51. Fundraising supplemented our income by \$8,854.90. Internal donations (UCW) a business donation and Weddings & Rentals contributed \$6,585.00 to our income. The remaining source of income comes from HST Recovery, GIC interest and other miscellaneous items.

Operating Expenses

The operating expenses of \$158,547.56 for 2017 when compared to the operating income of \$173,315.60 resulted in a year end surplus of \$14,768.04.

Capital Income

The Capital Income totaled \$100,409.19. The source of income comes from capital fundraising, personal donations, Extension council grant & loan HST Recovery and GIC interest.

Capital Expense

The Capital Expenses of \$109,403.96 for 2017 when compared to the Capital Income of \$100,409.19 resulted in a year end deficit of \$8,994.77.

Proposed (Expense) Operating Budget for 2018

The proposed (Expense) Operating Budget was developed based on our expenditures in 2017 adjusting the budget to meet expected increases and some decreases in 2018.

The proposed budget for 2018 is \$174,143.00 which is an increase of \$6,952.36 or approximately 4% from 2017. The increases in the budgeted items are mostly based on routine increased expenses each year, including salary increases. One line item to notice is the addition of a proposed budget for the care and upkeep of the cemetery. The trustees requested this addition to aid them in handling the increasing costs of caring for the cemetery when the number of sale of plots is decreasing. You will note also that we now have the added expense of paying off a loan and cost of a sabbatical.

Proposed (Income) Operating budget for 2018

The proposed (Income) Operating Budget for 2017 is \$174,143.00 which is an increase of \$\$6,952.36 or approximately 4% from 2017. This increase has been made in an attempt to have a **balanced Income/Expense Budget**. You will notice that we have included the Potentials Grant of \$5,525.00 given to help with Rev. James' 3 month sabbatical leave.

Financial Outlook

If we stay the course and repeat our success in 2017, we will surely be able to once again present a year end surplus in 2018. This is assuredly a representation of a very devoted and generous congregation that we are all blessed to be a part of.

Annual Report for 2017

Thank you for your continuing support for the Caribbean Workers Outreach Project. In 2017 we celebrated the 25th anniversary of the project through which a sawmill group of Christian volunteers in Lincoln and Niagara-on-the-Lake have ministered to Art cultural workers(mails Jamaican) who come each year to assist in farm work to benefit Niagara farmers. Each spring hundreds of men (an a small group of women) leave family and home to travel to Niagara to work from 5-9 months, living on farms and saving or sending home their pau to support them and their families throughout the year. They cope with lung working hours, extreme weather, isolation and loneliness. CWOP offers support to workers through five programmes.

- 1. Regular worship services are held in Lincoln and Niagara on Sunday evenings from late April to the end of June and both sides host a closing service at the end of August or early September. Each week volunteer drivers bring workers to services and return them to their farms. Local churches provide fruit, juice and pastries for the workers after each service. Visitors are welcome.
- 2. Each year two ministers from the United Church of Jamaica and Cayman Islands come to Niagara for five weeks each, to lead worship and to visit workers on farms in the evenings to offer friendship and support, sharing news from home and prayer. We need volunteer drivers to help the ministers to travel from farm to farm and also to help workers get to Sunday evening services.
- 3. Each year we host workers from both sides for two events with friendly competition. A dominoes match in Lincoln on a Saturday evening and a Cricket Match in NOTL on a Sunday afternoon are highlights of the summer. Participants in the Cricket Match get team shirts and everyone shares in a special meal. There is no charge to workers for these events and transportation is provided.
- 4. We have a fund to provide benevolent support to workers who experience the death of a parent, spouse or child in Jamaica. This helps with the cost of airfare or funeral expenses. Support may be available at other times of crisis.
- 5. We host a breakfast early in June for ministers from Niagara and Lincoln churches to tell them about the programme, to offer an opportunity to meet with Jamaican ministers and to enlist their support in encouraging volunteers from their churches to sign up for our ministry.

This year we also prepared and hosted a 25th Anniversary celebration service at Mountainview United Church. Over 400 Jamaicans and Canadians attended the service. Everyone received an Anniversary t-shirt, through the sponsorship of Jamaica National and worship was joyful and spirit-filled.

Rev. Dave Pritchard (convenor) and Pastor Jim Wright serve on the Project executive. On the Lincoln side Rev. Anita Spiller, Neil Ryckman and Annelies de Groot (treasurer) continue to be involved. On the NOTL side Nancy King, Donna Brown (secretary), Dave & Claudeen Bell and Carol Miller continue. The Jamaican ministers who joined us this year were Rev. Norlene Jackso(May) and Rev Wayne Wisdom (June)

We will be making some changes in the coming year and each side will have a different outreach, but will continue to care for workers and shre the love of Christ with our offshore friends and newcomers. We continue to look for leaquers and helpers in Lincoln and Niagara-on-the-Lake who can assist us in our shared ministry. Please contact me (information above) to join us. David Pritchard
